KEHE DISTRIBUTORS, LLC SUPPLIER RECALL NOTIFICATION PROCEDURE

Dear Supplier Partner,

Below outlines the procedure that must be followed for all recalls:

RECALL NOTIFICATION:

<u>Supplier shall immediately give written notice to KeHE of all recalls and</u> withdrawals by email to:

keherecall@kehe.com

All recall notifications <u>MUST</u> go to this email address. Recall notifications emailed solely to KeHE employees that do not copy <u>keherecall@kehe.com</u> are not compliant with KeHE's Policies and Procedures.

Recall Notice must include, without limitation:

- Date and Time of Notification to KeHE
- Reason for and Severity of the Recall
 - Classification of Recall (see FDA Classifications)
 - Quality or Health Risk (For example, undeclared allergen, quality defect, etc.)
- Product Description
 - Insert "FOOD", "DRUG", "MEDICAL DEVICE", "CONSUMER PRODUCT" etc.
- All Relevant UPCs/GTINs and LOT Codes, <u>AND</u> at least one of the following:
 - Best By Date(s), Sell By Date(s), or Expiration Dates(s)
- Enclosure of Product Label
- First Date Defective Product was received by KeHE
- Total Cases of Defective Product that was received by KeHE
- List of KeHE Distribution Centers that received Defective Product
- Disposition wishes of the Defective Product, including both at KeHE's DC and at the retail store level.
- Supplier Contact Information for all questions (email must be provided)
- All other relevant information, including, but not limited to, whether or not you have already been in contact with a government agency (i.e. FDA, USDA), and if so, the contact information of any inspector.

Acme 2 Oz. Pepperoni Pizzas, UPC #12345678910 with "Best By" date of January 2023; Lot Code 12345.

This voluntary recall is due to an undeclared allergen, milk, and is such classified as a Class 1 Recall according to FDA guidelines. The recall is currently limited to the 2 ounce pepperoni pizza and does not extend to other Acme Foods products.
